3. Candidates will be required to bring original documents (Educational, Domicile and Experience Certificate etc.) along with one set of attested copies of all documents at the time of interview.
4. The Authority reserves the right not to fill any vacancy or to reduce/increase the number of vacancies, if the circumstances so warranted at the time of final selection.
5. The candidates working in Public Sector Departments/Organizations shall apply through proper channel and have to submit Departmental Permission Certificates from the respective department/employers at the time of interview, failing which they will not be allowed to participate in interview.
6. In addition to 5 years general age relaxation already allowed in the above table, further age relaxation shall be admissible as per (Relaxation of Upper Age Limit) Rules, 1993.
7. Minimum and Maximum age shall be calculated on the closing date for receipt of applications.
